I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named above; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity. I hereby release, discharge, and covenant not to sue Sonshine Gymnastics, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim.

# Birthday Party Guidelines

Dear Parents,

Thank you for choosing Sonshine Gymnastics to celebrate your child's birthday party. We are confident this will be a fun and exciting time that you and your child will remember for years to come!

## On party day, it's important to keep the following in mind:

-  **Friday parties** are for children ages 3 & up.
-  **Saturday parties** are for children ages 4 & up. If a 3 year old attends, they'll need to be able to go in the gym without a parent. 2 year olds aren't permitted on the floor.
-  Guests must be old enough to take direction from the coaches. Children are only allowed on the gym floor when accompanied by a coach. Parents of your guests can stay for the party, although for safety reasons, aren't permitted to enter the gym to participate in the activities. They may take pictures and video tape from the cubby/observation area. Be sure to let your guests know about this policy.
-  The inflatable & Rocket Blaster bungee ride are used only on Saturdays. *Equipment not guaranteed.* (Please note: The Rocket Blaster is for birthday child only.)
-  Plan on arriving fifteen minutes prior to your scheduled party time.
-  The parent/guardian of each guest **MUST** sign in at the front desk for their child to participate in the gym activities. When carpooling guests, you **MUST** bring in a signed waiver from parent of child. Each child will get a name tag.
-  Socks and shoes are to be placed in a cubby. The children can wait on the bleachers for the coach to begin the gym portion of the party. (No gum or food is allowed in the gym.)
-  Our party room is divided in half by a wall partition. When the time comes (approximately fifteen minutes before your gym time is over or earlier) we will help move your items into the appointed area and assist you in decorating or set-up as you wish to do. Banners attach well to the wall partition! Also, refrain from using streamers, confetti, piñatas, silly string, or trick candles (they set off the smoke alarms). This slows down the clean-up, and silly string is a fire hazard. Time is limited in the party room. You may choose to open presents here or at home. Please stay on schedule so the next party will have time to set up their decorations. We will clean up for you!
-  Sonshine will provide ribbons that you may give to the birthday guests or place in their "goody bags". These are to be handed out as they are leaving. The party hostess will also give the birthday child a Sonshine Gymnastics T-shirt.
